### **City Council Action Requested:**

Approve Ordinance 1244-13 Cancelling May 11, 2013 General Election & Declaring Each Unopposed Candidate Elected to Office

### **Background Information:**

Each candidate for the three Council seats for the May 11, 2013 General Election - Places 1, 3 and 5 - are unopposed. Under Sections 2.052 and 2.053 of the Texas Election Code, since all three candidates on the ballot are unopposed in the place they are seeking and thus would be the only names on the ballot for which the votes for the office they are seeking may be counted, and the City Council by order or ordinance declares so, the election is not held and each unopposed candidate is therewith elected to office. The Election Code further provides that if no election is to be held on election day by the city, a copy of the order or ordinance shall be posted on election day at each polling place used or that would have been used in the election. The attached Ordinance No. 1244-13 if approved will cancel the election and declare Roland Goveas, Robert DeSoto, and Edward Lopez elected to City Council Place 1, City Council Place 3, and City Council Place 5, respectively.

The attached Order of Cancellation will be placed at the polling place, at City Hall, and on our web site.

Order of Cancellation

**ORDINANCE NO. 1244-13**

**AN ORDINANCE CANCELLING THE MAY 11, 2013 GENERAL ELECTION AND DECLARING EACH UNOPPOSED CANDIDATE ELECTED TO OFFICE; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the City of Richland Hills, Texas is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Local Government Code; and

**WHEREAS**, in accordance with law a general election has been ordered for May 11, 2013, for the purpose of electing City Council members to serve on the City Council of the City of Richland Hills; and

**WHEREAS**, no proposition is to appear on the ballot in that election; and

**WHEREAS**, the city secretary has certified in writing that each candidate on the ballot is unopposed for election to office, attached hereto as Exhibit "A"; and

**WHEREAS**, the filing deadlines for placement on the ballot and declaration of write in candidacy has passed; and

**WHEREAS**, in these circumstances Subchapter C of Chapter 2 of the Election Code authorizes a governing body to declare each unopposed candidate elected to office and to cancel the election.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RICHLAND HILLS, TEXAS:**

**SECTION 1.**

The following candidates, who are unopposed in the May 11, 2013 general election are hereby declared elected to office, and shall be issued a certificate of election:

City Council Place 1	Roland Goveas
City Council Place 3	Robert DeSoto
City Council Place 5	Edward Lopez

**SECTION 2.**

The May 11, 2013 General Election is hereby cancelled.

**SECTION 3.**

The city secretary is directed to post a copy of this ordinance at each designated polling place on May 11, 2013.

**SECTION 4.**

This ordinance shall be cumulative of all provisions of ordinances of the City of Richland Hills, Texas, except where the provisions of this ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

**SECTION 5.**

It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this ordinance are severable, and if any phrase, clause sentence, paragraph or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the City Council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

**SECTION 6.**

This ordinance shall be in full force and effect from and after its passage and it is so ordained.
