Each director shall hold office for the term for which the director is appointed unless sooner removed or resigned. A vacancy occurring on the board of directors through death, resignation or otherwise shall be filled by appointment by the City Council for the remainder of the vacating member's term.

The chairman of the Board shall be the mayor or mayor pro-tem of the City.
